**Note I:** The interview call letters indicating date, time and venue of the interview have been sent to the above shortlisted candidates at their registered email address. Candidates are requested to check their mailbox, including spam and junk box for the same.

It is also advised to bring one set of photocopies of their original documents on the day of interview. In case, there is discrepancy in name of the candidate or their parents



**in any document viz-a-viz Online application and Matriculation Certificate, original affidavit with one photocopy should be produced on the day of Interview.**

**Note II:** Candidates may also refer to Para 1(i) of the important instructions and Para 12(m) under Detailed Notice of [Advertisement Number 1A/2022-23](#) (reproduced below):

Para 1 (i) - "Before applying, candidates should ensure that they fulfil the eligibility criteria for the advertised posts. The Reserve Bank of India Services Board, hereinafter referred to as 'Board', would admit to the examination all the candidates applying for the post with the requisite fee/intimation charges (as applicable) based on the information furnished in the [ONLINE application](#) and shall determine their eligibility only at the final stage, i.e., interview stage. If at that stage, it is found that any information furnished in the ONLINE application is false/incorrect or if according to the Board, the candidate does not satisfy the eligibility criteria for the post, his/her candidature will be cancelled and he/she will not be allowed to appear for interview and can be removed from service without notice, if he/she has already joined the Bank."

Para 12(m) – "In all matters regarding eligibility, conduct of examinations, interviews, assessment, prescribing minimum qualifying standards in both the Examination and interview, in relation to number of vacancies and communication of result, the Board's decision shall be final and binding on the candidates and no correspondence shall be entertained in this regard."

**Note III:** RTI queries pertaining to the said recruitment will be entertained only after declaration of the final results for the said post.
