Minutes of Pre-Bid Meeting – E-Tender for Appointment of Concurrent Auditor from October 01, 2025 to September 30, 2026 by Reserve Bank of India, Guwahati Tender No. – RBI/Guwahati/HRMD/4/25-26/ET/262

The Pre-bid meeting for the captioned e-Tender was held on July 14, 2025 at Video Conference Room, 4th Floor, Reserve Bank of India (RBI), Guwahati Office. The meeting was attended by Officials of ABC Cell, Human Resource Management Deaprtment (HRMD), RBI, Guwahati (hereinafter referred to as the "Bank") and representatives from Chartered Accountant (CA) Firms. The list of Officials from RBI, Guwahati and the CA firms who attended the meeting is enclosed in the Annexure to this document.

2. Following the brief introduction by the Bank, various queries raised by the prospective bidders/ interested firms, which were clarified. Summary of the same is as under:
