3. Tender Forms received after 15:00 hrs on November 15, 2021 will not be accepted in any circumstances. The tenderer shall sign and stamp all the pages of this tender document
4. Tender will be opened on November 15, 2021 at 16:00 hrs in the presence of General Manager & Officer-in-Charge, Reserve Bank of India, Gangtok or any other authorized official and the tenderer or their representative who choose to be present at the time of opening of tenders.

6. The tenderer may check the vehicle at the Bank's premises during Bank's working hours (10:00 am to 5:45 pm) on November 03, 2021 before quoting their price.
7. Highest Bidder/tenderer will be the successful tenderer. Successful tenderer shall make the payment only through NEFT mode.
8. Car will be handed over only after the receipt of payment of quoted amount (including applicable taxes).
9. GST shall be paid over and above the quoted price.
10. Successful bidder/tenderer shall be liable to pay any other applicable tax or any increase in tax other than the mentioned GST of 18% over and above the overall quoted price.
11. Successful bidder shall submit necessary Forms duly signed for change of ownership in the Registration Certificate (RC), RTA records, Insurance records, etc. and arrange for change. Physical possession of the car shall be handed over after completion of necessary paperwork.
