Transport and delivery of coins by closed cash vans/ closed vehicles_to the currency chests / small coin depots/other offices situated at various places in the state of Kerala and Mahe as may be required by Reserve Bank of India with carrier's risk.

Scope of Work

The tenderer shall supply sufficient number of fully covered container trucks having metallic body of sufficient thickness, preferably bullet / tamper proof with secure tamper proof double locking arrangement, enabled with Global Positioning System (GPS) for the transportation of coins packed in bags from:

- i. RBI, Thiruvananthapuram to currency chests located in the jurisdiction with carrier's risk.
- ii. RBI, Thiruvananthapuram to India Government Mint, Outstation RBI Issue Offices with carrier's risk.

Eligibility Criteria

The tenderers must be experienced, resourceful, and financially sound and licensed entity (company/partnership/proprietary firm, etc.) having:

- Valid license under the Kerala Private Security Agencies (Private Security to Cash Transportation Activities) Rules, 2020 to engage in the business of private security agency in the state of Kerala.
- 2. Minimum five years of experience in undertaking similar work
- Minimum average annual turnover of at least 25% of estimated expenditure of the contract during the last three financial years supported by audited financial statements.
- 4. Positive net worth as per the latest audited balance sheet. The tenderers shall submit solvency certificate duly certified by the bank.
- Minimum number of 5 fully covered closed vans/ vehicles of minimum 7.5 MT capacity having metallic body of sufficient thickness, preferably bullet / tamper proof with secure tamper proof double locking arrangement, enabled with Global Positioning System (GPS).

- 6. The applicant should ensure that the vehicles provided should be of less than 10 years and must be road worthy, that those have valid permit issued by RTO, that up to- date vehicle tax has been paid, that insurance cover is available, and that the driver of the vehicle has a valid driving license.
- 7. The applicant shall have Permanent Account Number (PAN) and GSTN number, as applicable to discharge the duties.
- 8. The characters and antecedents of the drivers and cleaners of the transport vehicles should be verified and certified by the Police and the Transport Operator should provide full details and photographs of drivers and cleaners engaged by them.
- 9. The applicant shall have an Office/ local representative within Municipal area of the Regional Office of the Bank for execution of contract.
- 10. The applicant shall maintain an account with any of the scheduled commercial banks. The name of the bank and nature of account maintained should be furnished to the Bank.
- 11. Applicants should be aware of the formalities required for e-tendering and should adhere to the process requirements as stipulated by the agency(MSTC) associated with e-tendering.
- 12. Earnest Money Deposit (EMD) as fixed by the Bank from time to time will be required to be paid by the applicants at the time of bidding. However, no interest will be paid on the EMD deposited and refunded or retained with the Bank.
- 13. Exemptions with respect to tender set fees, Earnest Money Deposit, and minimum prior work experience and turnover, if any, will be granted to the applicant registered in MSE (Micro and Small Enterprises) category subject to fulfilling the criteria thereof.
- 14. The applicant should provide details of services provided at other public/private institutions and turnover/audited balance sheets of last three years, GST registration & IT returns.
- 15. The decision of the competent authority in all matters shall be final and binding on all applicants.

- Proof of Licence issued by competent authority to engage in the business of private security agency in the state of Kerala as per Kerala Private Security Agencies (Private Security to Cash Transportation Activities) Rules, 2020.
