6. The tenders will be opened at 3:00 PM on October 07, 2022, in the presence of the tenderers or their authorised representatives who choose to be present.
7. Tenderers can inspect the car to acquaint themselves with the conditions etc., before quoting their rates and can obtain required particulars from the **Asst. General Manager, Estate Section, Reserve Bank of India, P. B. No. 3065, Ernakulam North, Kochi 682 018** and quote firm rates under column '**Amount Quoted**' in the price bid of the tender form. Car can be inspected between 11.00 AM and 4.00 PM on September 22, 2022, and/or September 23, 2022.
8. Tender amount (the total amount quoted in price bid of the tender) should be the net amount payable to the Bank. All other expenses, charges, taxes etc., shall be borne by the buyer.
9. Tenderers shall give their bid only in the tender format given in the tender. Bid quoted in a format other than the one furnished by the Bank will not be considered. Tenderer who quotes the highest price for the car shall be the successful tenderer. Successful tenderer shall **deposit the entire quoted**

amount within ten working days of acceptance of the tender by way of **NEFT/RTGS to the Bank's account as shown above OR by way of Bankers cheque / Demand draft** drawn in favour of Reserve Bank of India (payable at Thiruvananthapuram). Successful bidder shall be liable to pay any other tax or any increase in tax, if applicable.
