Renovation (Civil Work) of the work area for the proposed Issue Department in Annexe Building of RBI, Chandigarh, Sector-17A

Reserve Bank of India, Sector 17A, Chandigarh invites e-Tender from eligible and willing firms for undertaking Renovation (civil work) of Issue Department in Bank Premises. The estimated cost of work is ₹26,10,000/- (including GST) only.

2. **Only those firms, who are empanelled in Northern Offices of Reserve Bank of India (Jammu, Chandigarh, Dehradun, New Delhi, Jaipur, Kanpur and Lucknow) in categories from ₹20.00 / ₹25.00 Lakh to ₹50.00 Lakh for civil work and registered on MSTC portal will be able to take part in the Tender process.** The tender document is available on website www.rbi.org.in for download.

3. Tender shall be submitted online in two parts. Part-I of the tender will contain the Bank's standard technical and commercial conditions for the proposed work, which must be agreed to by the tenderers. Part-II of the tender will contain Bank's schedule of quantities and tenderer's price bid to be submitted online.

4. The firms fulfilling the eligibility criteria and desirous of being considered for award of the work should upload all the required documents at www.mstcecommerce.com/eprochome/rbi on or before **December 19, 2022 till 11:00 AM**.
