The following queries / issues were raised / discussed during the pre-bid meeting. The clarifications given by the Bank with respect to each of these queries / issues are as follows:

1	Provision of civil works for inlet/outlet piping work will be done by the Bank?	Clarified that the Bank will make suitable arrangements for all the Civil works.
2	Whether the gaps on the wall for the period after dismantling the old system and before installing the new system can be filled/covered by Bank?	Clarified that the Bank will make suitable arrangements for all the Civil works.
3	Whether the rate are to be quoted inclusive of GST?	The Bank has clarified that the: i. For Item No. 1 and 2 of the Price Bid of the Tender Document, the price should be quoted excluding GST . ii. For Item No. 3 and 4 of the Price Bid of the Tender Document, the

		price should be quoted inclusive of GST. The total amount will automatically be calculated by the system.
4	Completion Time	The work has to be completed within 3 months from the 10 th day of issue of Work order.
