The Employer / Bank shall thereafter ascertain and certify in writing under his hand what (if anything) shall be due or payable to or by the Employer / Bank and expense or loss which the

Employer / Bank shall have been put to in procuring the works to be completed and the amount, if any, owing to the contractor and the amount which shall be so certified shall thereupon be paid by the Employer / Bank to the contractor or by the contractor to the Employer / bank, as the case may be, and the certificate of the Engineer-in-charge shall be final and conclusive between the parties. The contractor, whose contract is determined as above, shall not be allowed to participate in the tendering process for the balance work, if resorted to by the Employer / Bank.

In the event of above courses being adopted by the Engineer-incharge, the contractor shall have no claim to compensation for any loss sustained by him by reasons of his having purchased or procured any materials or entered into any engagements or made any advances on account or with a view to the execution of the work or the performance of the contract. And in case action is taken under any of the provision aforesaid, the contractor shall not be entitled to recover or be paid any sum for any work thereof or performed under this contract unless and until the Engineer-incharge has certified in writing the performance of such work and the value payable in respect thereof and he shall only be entitled to be paid the value so certified.





and hence not require the whole or any part of the works to be carried out, the Engineer-in-charge shall give notice in writing to that effect to the contractor and the contractor shall act accordingly in the matter. The contractor shall have no claim to any payment of compensation or otherwise whatsoever, on account of any profit or advantage which he might have derived from the execution of the works in full but which he did not derive in consequence of the foreclosure of the whole or part of the works.

The contractor shall be paid at contract rates, full amount for works executed at site and, in addition, a reasonable amount as certified by the Engineer-in-charge for the items hereunder mentioned which could not be utilized on the work to the full extent in view of the foreclosure:

i) The Employer / Bank shall have the option to take over contractor's materials or any part thereof either brought to site or of which the contractor is legally bound to accept delivery from suppliers (for incorporation in or incidental to the work) provided, however Employer / Bank shall be bound to take over the materials or such portions thereof as the contractor does not desire to retain. For materials taken over or to be taken over by Employer / Bank, cost of such materials as detailed by Engineer-in- charge shall be paid. The cost shall, however, take into account purchase price, cost of transportation and deterioration or damage which may have been caused to materials whilst in the custody of the contractor.

The contractor shall, if required by the Engineer- in-charge, furnish to him, books of account, wage books, time sheets and other relevant documents and evidence as may be necessary to enable him to certify the reasonable amount payable under this condition.

Carrying out part work at risk & cost of contractor.

Clause - 14.

If contractor:

- i) At any time makes default during currency of work or does not execute any part of the work with due diligence and continues to do so even after a notice in writing of 7 days in this respect from the Engineer-in-charge or
- ii) Commits default in complying with any of the terms and conditions of the contract and does not remedy it or takes effective steps to remedy it within 7 days even after a notice in writing is given in that behalf by the Engineer-in-charge or
- Fails to complete the work(s) or items of work with individual dates of completion, on or before the date(s) so determined and does not complete them within the period specified in the notice given in writing in that behalf by the Engineer-in-charge.

The Engineer- in-charge without invoking action under clause 3 may, without prejudice to any other right or remedy against the contractor which

have either accrued or accrue thereafter to the Employer / Bank, by a notice in writing to take the part work / part incomplete work of any item(s) out of his hands and shall have powers to:

- a) Take possession of the site and any materials, constructional plant, implements, stores, etc., thereon; and/or
- b) Carry out the part work / part incomplete work of any item(s) by any means at the risk and cost of the contractor.

The Engineer-in-charge shall determine the amount, if any, is recoverable from the contractor for completion of the part work / part incomplete work of any item(s) taken out of his hands and execute at the risk and cost of the contractor. The liability of contractor on account of loss or damage suffered by the Employer / Bank, because of action under this clause shall not exceed 10% of the Contract price of the work.

In determining the amount, credit shall be given to the contractor with the value of work done in all respect in the same manner and at the same rate as if it had been carried out by the original contractor under the terms of his contract, the value of contractor's materials taken over and incorporated in the work and use of plant and machinery belonging to the contractor. The certificate of the Engineer-in-charge as to the value of work done shall be final and conclusive against the contractor provided always that action under this clause shall only be taken after giving notice in writing to the contractor. Provided also that if the expenses incurred by the Employer / Bank are less than the amount payable to the contractor at his agreement rates, the difference shall not be payable to the contractor.

Any excess expenditure incurred or to be incurred by Employer in completing the part work/ part incomplete work of any item(s) or the excess loss of damages suffered or may be suffered by Employer as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to Employer in law or as per agreement be recovered from any money due to the contractor on any account, and if such money is insufficient, the contractor shall be called upon in writing and shall be liable to pay the same within 30 days.

If the contractor fails to pay the required sum within the aforesaid period of 30 days, the Engineer-in-charge shall have the right to sell any or all of the contractors' unused materials kept at site etc. and adjust the proceeds of sale thereof towards the dues recoverable from the contractor under the contract and if thereafter there remains any balance outstanding, it shall be recovered in accordance with the provisions of the contract.

In the event of above course being adopted by the Engineer-in-charge, the contractor shall have no claim to compensation for any loss sustained by him by reason of his having purchased or procured any materials or entered into any engagements or made any advance on any account or with a view to the execution of the work or the performance of the contract.

The contractor shall treat all materials obtained during dismantling work at site (except material mentioned in the Bill of Quantity under rebate item and debris) etc, as the Employer's / Bank's property and such materials shall be disposed as per the specific instructions in this regard or in absence of the same to the best advantage of the Employer / Bank, according to the instructions in writing issued by the Engineer-in-charge.

Contractor liable for damages, defects during defect liability period.

Clause - 17.

If the contractor or his working people shall break, deface, injure or destroy any part of building in which they may be working, or any building, road, road kerb, fence, enclosure, water pipe, cables, drains, electric or telephone post or wires, trees, grass or grassland, or cultivated ground contiguous to the premises on which the work or any part is being executed, or if any damage shall happen to the work while in progress, from any cause whatever or if any defect, shrinkage, settlement or other faults appear in the work within Defects Liability Period stated in schedule 'F' or, if none stated, then within twelve months after a certificate final or otherwise of its completion shall have been given by the Engineer-in-charge as aforesaid arising out of defect or improper materials or workmanship, the contractor shall upon receipt of a notice in writing on that behalf and within such reasonable times as shall be specified therein, make the same good at his expense or in case of default the Engineer-in-charge may employ and pay other persons to amend and make good such defects,

shrinkage, settlements or other faults and all damages, loss and expenses consequent thereon or incidental thereto shall be made good and borne by the contractor and such damage, loss, expenses shall be recoverable from him by the Employer / Bank or may be deducted by the Employer / Bank, upon the Engineerin-charge's certificate in writing, from any money due or may become due to the contractor, or the Employer / Bank may in-lieu of such amending and making good by the contractor deduct from any money due to the contractor, a sum, to be determined by the Engineer-in-charge equivalent to the cost of amending such work and in the event of the amount retained as Security Deposit being insufficient, recover the balance from the contractor, together with any expense(s) the Employer / Bank may have incurred in connection therewith. Should any defective work have been done or material supplied by any sub-contractor employed on the works who has been nominated or approved by the Employer / Bank, the contractor shall be liable to make good in the same manner as if such work or material had been done or supplied by the contractor and been subject to the provisions of this clause. The contractor shall remain liable under the provisions of this clause notwithstanding the signing of any certificate or the passing of any accounts, by the Employer / Bank. The Security Deposit of the contractor shall not be refunded before the expiry of the Defect Liability Period after the issue of the certificate final or otherwise, as provided elsewhere.

ii) In case of maintenance and operation works of E&M services, the security deposit deducted from contractors shall be refunded within one month from the date of final payment or within one month from the date of completion of the maintenance contract whichever is earlier.

Setting out of works.

Clause - 18.

The contractor shall set out the works and shall be responsible for the true and perfect setting out of the same and for the correctness of the positions, levels, dimensions and alignment of all parts thereof. If at any time, any error in this respect shall appear during the progress of the works or within the Defect Liability Period after completion of the works, the contractor shall, if so required, at his own expense rectify such error to the satisfaction of the Engineer-in-charge.

The checking of any setting-out or of any line or level by the Engineer-incharge or his representative shall not in any way relieve the contractor of his responsibility for the correctness thereof and the contractor shall carefully protect and preserve all bench-marks, sight rails, pegs and other things used in setting out the works.

Failure on the part of contractor to obtain approval of Engineer-in-charge or failure to deploy qualified tradesmen will attract a compensation to be paid by contractor at the rate of Rs. 500/- per such tradesman per day. Decision of Engineer-in-charge as to whether particular tradesman possesses requisite skill and amount of compensation in case of default shall be final and binding.

The contractor shall also supply without charge the requisite number of persons with the means and materials, necessary for the purpose of setting out works, and counting, weighing and assisting the measurement for examination at any time and from time to time of the work or materials. Settlement Clause - 25. disputes Except where otherwise provided in the contract, all questions and arbitration. disputes relating to the meaning of the specifications, design, drawings and instructions here-in before mentioned and as to the quality of workmanship or materials used on the work or as to any other question. claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, designs, drawings, specifications, estimates, instructions, orders or these conditions or otherwise concerning the works or the

execution or failure to execute the same whether arising during the progress of the work or after the cancellation, termination, completion or

abandonment thereof shall be dealt with as mentioned hereinafter:

- i) The decision, opinion, direction, certificate of payment issued by the Engineer-in-charge in respect of all or any of the excepted matters as provided in the contract shall be final, conclusive and binding on the parties hereto and shall be without appeal. Such decision may be in the form of a final certificate or otherwise.
- ii) All other disputes and differences of any kind whatsoever arising out of or in connection with the contract or the carrying out of the works (whether during the progress of the works or after their completion and whether before or after the determination abandonment or breach of the contract) shall be referred to and settled by the Competent Authority of the Employer / Bank as specified in the schedule 'F'. The designated authority shall state its decision in writing within 28 days from the date of receipt of reference from the contractor.
- iii) But if the Competent Authority (CA) fails to give his decision within the aforesaid period or if either party be dissatisfied on any matter, it may, within 28 days after receiving notice of such decision, give a written notice to the other party requiring that the matters in dispute be arbitrated upon. Such written notice shall specify the matters, which are in dispute or difference of which such written notice has been given. If both the parties agree, a single arbitrator would be appointed for the purpose. In case there is no agreement on the appointment of arbitrator, the employer shall prepare a panel of three person's names and forward to the contractor to select one among them as arbitrator.

The arbitrator so appointed / selected shall confine herself / himself / themselves only to the dispute / difference referred to her / him / them while adjudicating and pronouncing his decision.

The arbitrator shall make her / his / their award within one year (or such further extended time as may be decided by her / him / them as the case may be with the consent of the parties) from the date of entering on the reference. In case during the arbitration proceedings the parties mutually settle or compromise their dispute or difference, on the parties filing their joint memorandum of the settlement or compromise, the arbitrator or the arbitrators as the case may be, shall make an award in terms of such settlement or compromise.

Upon any such reference, the decision on the cost incidental to the reference and award respectively shall be in the discretion of the arbitrator as the case may be, who may determine the amount thereof or direct the same to be taxed as between the party and party and shall direct by whom and to whom and in what manner the same shall be borne and paid. This submission shall be

deemed to be a submission to arbitration within the meaning of the Indian Arbitration and Conciliation Act, 1996 or any statutory modification thereof. The award of the arbitrator shall be final and binding on the parties. It is agreed that the contractor shall not delay the carrying out of the works by reason of any such matter, question or dispute being referred to arbitration, but shall proceed with the works with all due diligence and shall until the decision of the arbitrator is given, abide by the decision of the Employer / Bank. No award of the arbitrator shall relieve the contractor of her / his / their obligations to adhere strictly to the Employer's / Bank's instructions with regard to the actual carrying out of the works. The Employer / Bank and the contractor hereby also agree that arbitration under this clause shall be a condition precedent to any right of action under the contract. The place of arbitration shall be as specified in Schedule 'F'.

Contractor to indemnify the employer against Patent Rights.

Clause - 26.

The contractor shall fully indemnify and keep indemnified the Employer / Bank against any action, claim or proceeding relating to infringement or use of any patent or design or any alleged patent or design rights and shall himself pay any royalties, license fees etc, which may be payable in respect of any article or part thereof included in the contract or damages cost and charges of all and every sort that may be legally incurred in respect thereof. In the event of any claims made under or action brought against the Employer / Bank in respect of any such matters as aforesaid, the contractor shall be immediately notified thereof and the contractor shall be at liberty, at his own expense, to settle any dispute or to conduct any litigation that may arise therefrom, provided that the contractor shall not be liable to indemnify the Employer / Bank if the infringement of the patent or design or any alleged patent or design right is the direct result of an order passed by the Engineer-in-charge in this behalf.

Lumpsum provisions tender

Clause - 27.

When the estimate on which a tender is made includes lump sum in respect of parts of the work, the contractor shall be entitled to payment in respect of the items of work involved or the part of the work in question at the same rates as are payable under this contract for such items, or if the part of the work in question is not, in the opinion of the Engineer-in-charge payable of measurement, the Engineer-in-charge may at his discretion pay the lump-sum amount entered in the estimate, and the certificate in writing of the Engineer-in-charge shall be final and conclusive against the contractor with regard to any sum or sums payable to him under the provisions of the clause.

Clause - 28.

Nominated sub-contractors.	(i)	All specialists, merchants, tradesman and other executing any work of supplying and fixing any goods for which prime cost prices or provisional sums are included in the Schedule of Quantities and / or specifications who may be nominated or selected by the Engineer-in-charge are hereby declared to be sub-contractors employed by the contractor and are herein referred to as nominated sub-contractors. No nominated sub-contractor shall be employed on or in connection with the works against whom the contractor shall make reasonable objection or (save where the Employer / Bank and contractor shall otherwise agree) who will not enter into a contract provided:

It is an agreed term of the contract that the sum of money or moneys so withheld or retained under the lien referred to above by the Employer / Bank will be kept withheld or retained as such by the Employer / Bank till the claim arising out of or under the contract is determined by the arbitrator (if the contract is governed by the arbitration clause) or by the competent court, as the case may be and that the contractor will have no claim for interest or damages whatsoever on any account in respect of such withholding or retention under the lien referred to above and duly notified as such to the contractor. For the purpose of this clause, where the contractor is a partnership firm or a limited company, the Employer / Bank shall be entitled to withhold and also have a lien to retain towards such claimed amount or amounts in whole or in part from any sum found payable to any partner / limited company as the case may be, whether in his individual capacity or otherwise.

The Employer / Bank shall have the right to cause an audit and technical examination of the works and the final bills of the contractor including all supporting vouchers, abstract, etc, to be made after payment of the final bill and if as a result of such audit and technical examination any sum is found to have been overpaid in respect of any work done by the contractor under the contract or any work claimed to have been done by him under the contract and found not to have been executed, the contractor shall be liable to refund the amount of over-payment and it shall be lawful for the Employer / bank to recover the same from him in the manner prescribed in sub-clause (i) of this clause or in any other manner legally permissible; and if it is found that the contractor was paid less than what was due to him under the contract in respect of any work executed by him under it, the amount of such under payment shall be duly paid by the Employer/bank to the contractor, without any interest thereon whatsoever.

It is an agreed term of the contract that the sum of money so withheld or retained under this clause by the Employer / Bank will be kept withheld or retained as such by the Employer / Bank or till his claim arising out of the same contract or any other contract is either mutually settled or determined by the arbitration clause or by the competent court, as the case may be and that the contractor shall have no claim for interest or damages whatsoever on this account or on any other ground in respect of any sum of money withheld or retained under this clause and duly notified as such to the contractor.

Return of surplus materials.

Clause - 30.

Notwithstanding anything contained to the contrary in this contract, where any materials for the execution of the contract are procured with the assistance of the Employer / Bank by purchases made under orders or permits or licenses issued by Government, the contractor shall hold the said materials economically and solely for the purpose of the contract and not dispose them without the written permission of the Employer / Bank and return it to the Employer / Bank, if required by the Employer / Bank, all surplus materials that may be left with him after the completion of the contract or at its termination for any reason whatsoever on being paid or credited such price as the Engineer-incharge shall determine having due regard to the condition of the materials. The price allowed to the contractor however shall not exceed the purchase price thereof inclusive of sales tax, octroi and other such levies paid by the contractor in respect thereof. The decision of the Engineer-in-charge shall be final and conclusive. In the event of breach of the aforesaid condition, the contractor shall in addition to throwing himself open to action for contravention of the terms of the license or permit and / or for criminal breach of trust, be liable to the Employer / Bank for all moneys, advantages or profits resulting or which in the usual course would have resulted to him by reason of such breach.

Water and electric power supply for work.

Clause - 31.

Bank will make available water and electricity power supply required at one point free-of-cost. Contractor shall make her / his / their own arrangement for further extension of connection if any required with safety fixtures and nothing extra will be paid for the same.

Employer's water supply, if available.

Clause -32.

Water if available may be supplied to the contractor by the Employer at free of cost subject to the following conditions:

The Employer / Bank do not guarantee to maintain uninterrupted supply of water and it will be incumbent on the contractor(s) to make alternative arrangements for water at her / his / their own cost in the event of any temporary break down in the water mains so that the progress of her / his / their work is not held up for want of water. No claim of damage or refund of water charges will be entertained on account of such break down.

Insurance in respect of damages to persons and property.

Clause - 33.

i)

The contractor shall be responsible for all injury or damage to persons, animals or things, and for all damage to property which may arise from any factor omission on the part of the contractor or any sub-contractor or any nominated sub-contractor or any of their employees. The liability under this clause shall cover also interalia any damage to structures, whether immediately adjacent to the works or otherwise, any damage to roads, streets, footpaths, bridges as well as damage caused to the building and other structures and works forming the subject matter of this contract. The contractor shall also be responsible for any damage caused to the buildings and other structures and works forming the subject matter of this contract due to rain, wind, frost or other inclemency of weather. The contractor shall indemnify and keep indemnified the Employer / Bank and hold him harmless in respect of all and any loss and expenses arising from any such injury or damage to persons or property as aforesaid and also against any claim made in respect of injury or damage, whether under any statute or otherwise and also in respect of any award or compensation or damage consequent upon such claims. The contractor shall, at her / his / their own expense, effect and maintain till issue of the virtual completion certificate under this contract, with an insurance company approved by the Employer / Bank, an All Risks Policy of Insurance for the full amount of the contract including earth quake risk in the joint names of the Employer / Bank and the contractor (the name of the former being placed first in the policy) against all risks as per the standard all risk policy for contractors and deposit such policy or policies with the Employer / Bank before commencing the works.

The Contractor shall reinstate all damage of every sort mentioned in this clause so as to do delivery of the whole of the works complete and perfect in every respect and so as to make good or otherwise satisfy all claims for damage to property or third parties.

The contractor shall also indemnity and keep indemnified the Employer / Bank against all claims which may be made against

the Employer / Bank by any person in respect of anything which may arise in respect of the works or in consequence thereof and shall at his own expense, effect and maintain until the virtual completion of the contract, with an Insurance Company approved by the Employer / Bank a Policy of Insurance in the joint names of the Employer / Bank and the contractor (name of the former being placed first in the policy) against such risks and deposit such policy or policies before commencement of the works.

The minimum limit of the coverage / liability under the policy shall be Rs.2.00 Lakh per person for any one accident or occurrence and Rs.5.00 Lakhs in respect of damage to property for any one accident or occurrence. The Contractor shall also indemnify the Employer / Bank against all claims which may be made upon the Employer / Bank, whether under the Workmen's Compensation Act or any other statute in force, during the currency of this contract or at Common Law in respect of any employee of the contractor or sub-contractor and shall at her / his / their own expense effect and maintain until the Virtual Completion of the contract with an Insurance Company approved by the Employer a Policy of Insurance against such risks and deposit such policy or policies with the Employer from time to time during the currency of this contract.

In default of the contractor insuring as provided above, the Employer / Bank may so insure and may deduct the premiums paid from any money due or which may become due to the contractor.

The contractor shall be responsible for any liability which may not be covered by the insurance policies referred to above and also for all other damages to any person, animal or defective carrying out of this contract, whatever, may be the reasons due to which the damage shall have been caused.

The contractor shall also indemnify and keep indemnified the Employer / Bank against all and any costs, charges or expenses arising out of any claim or proceedings relating to the works and also in respect of any award of damage or compensation arising therefrom.

Without prejudice to the other rights of the Employer / Bank against contractors in respect of such default, the Employer / Bank shall be entitled to deduct from any sums payable to the contractor the amount of any damages, compensation costs, charges and other expenses paid by the Employer / Bank and which are payable by the contractor under this clause.

The contractor shall upon settlement by the insurer of any claim made against the insurer pursuant to a policy taken under this clause, proceed with due diligence to rebuild or repair the works destroyed or damaged. In this event all the money received from the insurer in respect of such damage shall be paid to the contractor and the contractor shall not be entitled to any further payment in respect of the expenditure incurred for rebuilding or repairing of the materials or goods destroyed or damaged.

The contractor, in case of re-building or reinstatement after damage shall be entitled to such extension of time for completion as the Engineer-in-charge may deem fit, but shall, however, not be entitled to reimbursement by the Employer / Bank of any shortfall or deficiency in the amount finally paid by the insurer in settlement of any claim arising as set out herein.

Without prejudice to his liability under this clause, the contractor shall also cause all nominated sub-contractors to effect, for their respective portions of the works similar policies of insurance in accordance with the provisions of this clause and shall produce or cause to produce to the Employer / Bank such policies. The contractor shall not permit a nominated sub-contractor to commence work at the site unless said insurance policies are submitted. In the event of failure, of the sub-contractor to take out such policy or policies of insurance before commencing the works at the site, the contractor shall be responsible for any claim or damage attributable to the said sub-contractor.

Employment of technical staff and employees.

Clause - 34.

i)

Contractor's superintendence, supervision, technical staff & employees:

The contractor shall provide all necessary superintendence during execution of the work and all along thereafter as may be necessary for proper fulfillment of the obligations under the contract until the expiry of the 'Defects Liability Period' stated in **schedule** 'F'.

The contractor shall immediately after receiving letter of award of work and before commencement of the work, intimate in writing Engineer-in-charge, the name(s), qualifications, experience, age, address(s) and other particulars along with certificates, of the Project Manager, to be in charge of the work, representative technical and other representative(s) who will be supervising the work. Minimum requirement of such Project Manager and technical representative(s) and their qualifications and experience shall not be lower than specified in Schedule 'F'. The Engineerin-charge shall within 3 days of receipt of such communication intimate in writing his approval or otherwise of such a representative(s) to the contractor. Any such approval may at any time be withdrawn and in case of such withdrawal, the contractor

shall appoint another such representative(s) according to the provisions of this clause. Decision of the Employer / Bank shall be final and binding on the contractor in this respect. Such a Project Manager, principal technical representative and other technical representative(s) shall be appointed by the contractor soon after receipt of the approval from Engineer-in-charge and shall be available at site before start of work.

the provisions applicable to the principal technical representative under the clause shall also be applicable to other representative(s). technical The principal technical representative and other technical representative(s) shall be present at the site of work for supervision at all times when any renovation work is in progress and also present himself / themselves, as required, to the Engineer-in-charge and / or his designated representative to take instructions. Instructions given to the principal technical representative or other technical representative(s) shall be deemed to have the same force as if these have been given to the contractor. Technical Specifications

A. Technical specifications and requirements for the work to be executed.

The scope of work covers execution, completion and testing of the work of 'Repairs and waterproofing works on the terraces of third floor (northside wing), VIP Guest House, Executive Lounge & Security Officer's Flat on the fourth floor and erstwhile cooling tower & water tank area on the fifth floor of Reserve Bank of India, Main Office Building, Chennai - 600001' in accordance with drawings (if any) and specifications prepared by the Bank and as directed by the Engineer-in-Charge.

1.1 Quality:

Materials to be used for the work shall confirm to relevant Indian / International standards as far as procurable & best quality of their respective kinds as specified herein and shall be of approved make and shall comply strictly with the tests prescribed hereinafter or, where tests are not laid down, with the requirements of the latest edition of the relevant Indian / International standards approved by the Engineer-in-charge.

1.2 Inspection and testing:

Materials before used in the Works shall be subjected to inspection and testing, if so required by the Engineer-in-charge, as provided in the Conditions of Contract and elsewhere in the specifications. The cost of all samples required for such tests as per relevant standards shall be borne by the contractor and the same are deemed to be included in the rates of respective items. No materials shall be used in the works unless they have first been approved by the Engineer-in-charge or his representative(s).

1.3 Samples

Samples of all materials proposed to be used or incorporated in the works and to be supplied by the Contractor may be called for at any time by the Engineer or his representative.

1.4 Independent tests:

Independent tests and analysis of any of the materials, if required by the Engineer-incharge may be made from time-to-time by a testing house or analyst appointed by the Engineer / Employer / Bank in order to check the supplier's works, tests and analysis. The frequency, the procedure for the testing and acceptance criteria will be as stated in the respective BIS / International Codes. The contractor shall at her / his / their own expenses supply and deliver to an approved testing house or analyst such materials, as may be directed by the Engineer-in-charge. Should the result of any test be unsatisfactory to the Engineer-in-charge or her / his / their representative, the materials represented will be rejected. The testing of material(s) (Third party test), if required by the Engineer-in-charge shall be carried out through a government / approved laboratory and the testing charges, as per actuals shall be reimbursed by the Bank on production of vouchers / paid receipt.

Wherever testing facilities are not available in India, the contractors shall submit the manufacturers' batch test certificates of the batch of material(s) used in the work.

1.5 Technical specification of work:

1.5.1 Dismantling the damaged portions of 'China Mosaic' / plaster finish.

a) Scope of work under the item.

The scope of work under this item shall be for carefully dismantling, and removing the existing 'China Mosaic' finish along with base / bed mortar or plaster of any thickness over the weather-proof course / R.C.C slabs, masonry walls / parapet walls on the open terraces, using mechanical dry-cutters, chisel and hammer or any other approved methods, to expose the intact base layer (brick bat coba / Surkhi / screed / masonry / R.C.C), without damaging the weather-proof course / masonry / R.C.C and the adjacent areas, thoroughly cleaning the surfaces exposed after dismantling, using wire brush / brooms, after sprinkling water, shifting, lowering, disposing / stacking at location(s) shown by the Engineer-in-charge, within the Bank's premises and carting the debris away from the Bank's premises etc complete as directed by the Engineer-in-charge.

b) Mode of measurement.

Portions dismantled shall be divided into geometrical shapes and the area of such portions shall be worked out using appropriate formulae by measuring the dimensions correct to the nearest centimeters and considered for payment. The quantities shall be rounded-off to two decimal points.

1.5.2 Repairs to damaged R.C.C members.

a) Scope of work under the item.

The scope of work under this item shall be for providing and repairing the damaged R.C.C members like columns, roof slabs, beams, sill slabs of windows, coping of parapet walls, sunshades, lintels etc, comprising the following:

- i) Carefully dismantling and removing the loose / spalled plaster & concrete to expose the intact surfaces of the R.C.C members / corroded reinforcement bars, using hammer and chisel or any other approved methods, thoroughly cleaning the exposed surfaces of R.C.C members using clean water, wire brush etc, as directed by the Engineer-in-charge.
- ii) Thoroughly cleaning the corroded reinforcements including removing the rust scales using chisel, hammer and approved quality and make rust removing solutions / chemicals, used as per manufacturers' specifications, providing and applying a coat of approved make, two components, solvent borne zinc rich epoxy primer / corrosion passivator of approved make and brand, for the exposed surfaces of the steel reinforcements as per manufacturer's specifications and as directed by the Engineer-in-charge.
- iii) Providing and rendering shrinkage compensated / controlled, polymer modified, fibre reinforced, cementitious, ready to use, trowelable structural repair mortar of approved make and brand used as per manufacturers' specifications, for an

average thickness of up to 20 mm, to repair / re-habilitate the damaged R.C.C members true to plumb, line and level to make them up to the original shape & size of the members, after preparing the surface of the members to be repaired as per manufacturer's specification and as directed by Banks Engineer. If the average thickness of mortar exceeds 20 mm, it shall be done in layers and each subsequent layers of mortar as per the specifications above, shall be rendered (which shall be measured separately under item No. 1.5.3 below), after proper curing of the previous layer(s), all as directed by the Engineer-in-charge. Necessary scaffolding, curing, cleaning, disposing the dust / debris generated from the work and carting away the same from the Banks premises, cleaning of the surfaces stained / affected during execution of the item etc are also included in the scope of the work.

b) Mode of Measurement.

Actual surface area of the finished layer, for thickness up to 20 mm shall be worked out by measuring the average length and width, correct to the nearest centimeter and considered for payment. The quantities shall be rounded-off to two decimal points.

1.5.3 Providing and rendering additional layers of polymer modified cement plaster.

a) Scope of work under the item.

The scope of work under this item shall be for providing and rendering shrinkage compensated / controlled, polymer modified, fibre reinforced, cementitious, ready to use, trowelable structural repair mortar, all as per the specifications under item No. 1.5.2 above, but for additional layers of average thickness of 15 mm, as additional layers over the base layer(s) rendered as per item No. 1.5.2 above or subsequent additional layer(s) under this item. These subsequent layers shall be applied after proper curing of the previous layer(s), all as per the manufacturers specifications and as directed by the Engineer-in-charge. The scope of work also includes necessary scaffolding, curing, disposing the debris generated from the work, cleaning of the surfaces stained / tarnished by splashing of the chemicals / mortar etc.

b) Mode of Measurement.

Actual surface area of the finished layer(s), for an average thickness up to 15 mm shall be worked out by measuring the average length and width, correct to the nearest centimeter and considered for payment. The quantities shall be rounded-off to two decimal points.

1.5.4 Dismantling and removing the debonded / disintegrated / loose screed concrete / brick bat coba / Surkhi.

a) Scope of work under the item.

The scope of work under this item shall be for carefully dismantling and removing the debonded / disintegrated / loose screed concrete / brick bat coba / Surkhi, along with mortar in patches having regular geometric shapes, using mechanical cutters, chisel and hammer or any other approved method, shifting, lowering and disposing / stacking

at location(s) shown by the Engineer-in-charge, within the Bank's premises and carting away the dust / debris generated from the work, away from the Bank's premises.

b) Mode of Measurement.

Actual volume without any deduction for the voids shall be arrived at by measuring the average dimensions of the space left after removal of the materials, correct to the nearest centimeter and considered for payment. The quantities shall be rounded-off to two decimal points.

1.5.5 Providing, cutting, straightening, bending, tying and placing in position TMT bars as thermal reinforcement mesh / mat and shear-connectors.

a) Scope of work under the item.

The scope of work under this item shall be for providing, cutting, straightening, bending, tying using 18 SWG G.I binding wires, approved quality and make, 10 mm diameter Thermo-Mechanically Treated (TMT) bars of grade Fe-500D or more at a spacing of 200 mm c/c both ways and placing them in positions as thermal reinforcement meshes / mats on the top of the brick bat coba / Surkhi exposed after dismantling and removing the China Mosaic / plaster finish and screed concrete as per item No. 1.5.1 & 1.5.4 and 200 mm long bars as shear connectors to be inserted in to the holes / bores to be drilled in to the brickbat coba / Surkhi. The scope of work shall include providing, casting, curing and placing cover blocks having 50 mm x 50 mm x 50 mm dimensions, using C.M 1:3 made from Portland cement and washed river sand including tying the same to reinforcement bars at a spacing not exceeding 1.00 m c/c both ways to ensure proper cover to the reinforcements etc, complete as directed by the Engineer-in-charge. The rate shall include wastages, cost of binding wire etc. Authorized laps shall be measured and paid for. The rate shall be excluding drilling of holes / bores into the brick bat coba / Surkhi to insert the shear connectors and grouting the same, which are covered under the scope of work under item No. 1.5.6 below.

b) Mode of measurement.

The quantity (weight) shall be arrived at by measuring the length of the rebars correct to the nearest centimetre, theoretical or actual section weight of the rebars, whichever is less and be considered for payment. Authorized laps and chairs shall be measured while arriving at the quantity and considered for payment. Wastages will not be admitted.

1.5.6 Drilling holes / bores into the brick bat coba / Surkhi layer and fixing the shear connectors by inserting them into these holes / bores and grouting using anchor grouts.

a) Scope of work under the item.

The scope of work under this item shall be for drilling 12 mm diameter and 100 mm deep holes / bores at a spacing not exceeding 2.00 m c/c both ways, into the brick bat coba / Surkhi, exposed as per item No. 1.5.1 & 1.5.4 above and fixing the shear connectors by inserting them into these holes / bores and securing them by grouting using approved quality and make anchor grouts as directed by the Engineer-in-charge.

b) Mode of measurement.

The number of holes / bores drilled and filled with anchor grouts after inserting the shear connectors shall be counted and be considered for payment.

1.5.7 Providing and laying screed concrete.

a) Scope of work under the item.

The scope of work under this item shall be for providing, mixing, laying, spreading, grading, consolidating and finishing P.C.C made by manual batching and mixing, approved quality and make Portland Cement, approved quality washed river sand and 20 mm and down size graded granite metals in the ratio 1:2:4 and modified with approved quality and make integral waterproofing liquid admixture for concrete, plaster and mortars used at a dosage of 200 ml per 50 Kg of cement, as per the manufacturers specifications and as directed by the Engineer-in-charge, to make up the portions of screed concrete layer dismantled and removed from the top of the brick bat coba / Surkhi layer of weather-proof course, under item No. 1.5.4 above. The screed concrete shall be consolidated and finished smooth, using mechanical needle / platform vibrators, hand rammers, screeding bars, trowels and floats. Thread impressions using 3-4 mm diameter threads shall be made on the surface of the freshly laid screed concrete before the initial setting of the same, at a spacing not exceeding 0.60 m c/c in both directions. The scope of work shall include necessary shuttering, if required as per site conditions, curing, disposing and carting away the debris out of the Bank's premises etc as directed by the Engineer-in-charge.

b) Mode of measurement.

The actual volume of the laid and finished screed concrete shall be worked out by measuring the length, width and average thickness (average of thicknesses measured at random points) correct to the nearest centimeter. The quantities shall be rounded-off to two decimal points.

1.5.8 Making grooves and refilling them on the plastered surfaces of the parapet walls.

a) Scope of work under the item.

The scope of work under this item shall be for Making continuous grooves, having 10 mm width and 10 mm depth (200 mm above covings / fillets finished with China Mosaic), on the plastered vertical surfaces of the parapet walls of the open terraces, by cutting using mechanical rotary cutters and raking using chisel and hammer or any other approved method. These grooves shall be thoroughly cleaned using, jet of water / compressed air, wire brushes / brooms / vacuum cleaners etc, to make them free of dust, loose matter and laitance and filled & finished with approved make shrinkage compensated / controlled, polymer modified, fibre reinforced, cementitious, ready to use, trowelable structural repair mortar as per the manufacturer's specifications and as directed by the Engineer-in-charge. The rate shall include necessary curing, removing / cleaning the surplus material / spill outs / debris, disposing off and carting away the debris from the Bank's Premises etc complete as directed by the Engineer-in-charge, after application, finishing and curing of the liquid-waterproofing membrane to be applied as per item No. 1.5.9 below.

b) Mode of measurement.

The length of the grooves cut / made shall be measured correct to the nearest centimeter and considered for payment. The quantities shall be rounded-off to two decimal points.

1.5.9 Providing and applying Hybrid Polyurea Liquid membrane water-proofing system.

a) Scope of work under the item.

The scope of work under this item shall be for preparing the surface of the screed concrete / plaster on the top of the weather-proof course and vertical surfaces of walls / parapet walls up to 300 mm from the highest point of the finished surface of the weather-proof treatment on the open terrace by making the surface rough using mechanical grinding / buffing machines, thoroughly cleaning the surface using wire brush / brooms / dusters / emery papers / jet of clean water / compressed air equipment / heavy duty vacuum cleaners etc to remove the layer(s) of moss / fungi / algae / dust / oil / grease / loose particles / decayed matter, laitance etc, to expose the virgin surface, providing and filling / levelling the surface pits / undulations / dents with approved quality and make solvent free, high performance, non-slumping epoxy based bedding and repair mortar / grout as per manufacturer's specifications, providing and applying elastomeric hybrid polyurea liquid water-proofing membrane system comprising the following;

i) Opening and filling of surface dents / cracks.

Carefully cutting and opening the crevices / cracks having width and depth up to 10 mm, on the surface of the concrete / plaster finish on the top of the weather-proof course / parapet walls on the open terrace using mechanical cutters in 'V' shape in cross-section having width and depth up to 10 mm each, cleaning the same using compressed air equipment / heavy duty vacuum cleaners / clean jet of water / wire brush etc, providing, mixing, filling and finishing these cracks, dents, crevices, pits and holes on the surfaces with approved quality and make solvent free, high performance, non-slumping epoxy based bedding and repair mortar / grout as per the manufacturer's specifications and as directed by the Engineer-in-charge, including necessary curing, removing / cleaning the surplus materials / spill outs / debris, disposing and carting away the debris from the Bank's Premises etc complete as directed by the Engineer-in-charge.

ii) Spray applied epoxy primer.

Providing and applying two component, solvent free, fast setting / drying, high performance epoxy resin based liquid primer over the surfaces prepared as above, by means of a specially designed two / plural component, high pressure spraying equipment / roller as per manufacturer's specifications for an average thickness of not less than 100 microns.

iii) Sand broadcasting

Providing and applying approved quality and make dry silica / quartz sand by evenly broadcasting @ 0.75 Kg Per Sqm, over the entire area primed as per (ii) above, while the primer is still in tacky state. When sufficiently cured, the surface shall be cleaned to remove any loose sand.

iv) Spray applied elastomeric hybrid polyurea water-proofing membrane

Providing and applying fast setting / drying, two component, solvent free, 100 % solid content, Hybrid Polyurea, liquid, cold applied, elastomeric, seamless, spray applied water-proofing membrane, over the surface prepared as per (iii) above, up to and inside the grooves made as per item No. 1.5.8 above, using a specially designed, two / plural component, high pressure spray equipment as per manufacturer's specifications to achieve an average Dry Film Thickness of 2 mm. The finished water proofing membrane after curing shall have a tensile strength not less than 8 N/mm2 (MPa), elongation not less than 400%, Shore A hardness not less than 70 and Tear Strength not less than 30 N/mm.

v) <u>UV stable polyurethane topcoat</u>

Providing and applying two coats of two component, high solids, Polyurethane based UV stable protective top coat having white shade of approved quality and make, applied with roller / brush / using a specially designed, two / plural component, high pressure spray equipment as per manufacturer's specifications, over the water-proofing membrane applied as per (iv) above, within 12 to 24 hours after completion of the spray application of the water-proof membrane applied as per (iv) above to achieve a Dry Film Thickness (DFT) of not less than 100 microns.

The surfaces shall be suitably prepared as per manufacturers' specifications before application of each coat of chemicals including providing and treating the surfaces where growth of algae / fungi / moss is noticed with proprietary biocides. The chemicals / materials shall be applied / used strictly as per the manufacturer's specifications and instructions of Bank's Engineer. The scope of work shall include providing and making 50 mm x 50 mm fillets (coving) at junctions of floor and walls, wherever required, using polymer modified cement concrete prepared as under item No. 1.5.7 above including necessary curing. The rate shall also include, removing / cleaning the surplus material / spill outs / debris disposing and carting away the dust / debris generated from the work out of the Bank's premises. Bidders shall consider all required materials including handling, loading, unloading, leads, lifts, wastages, labour, tools, plants, machinery, transport etc required for successful completion of the work, while quoting the rates. The rate shall also include proper barricading of the area and providing temporary screens with proper supporting system, all as approved by the Engineer-in-charge around the area of work to prevent spreading of chemicals / dust to other areas during execution of work.

b) Mode of measurement.

The total surface area of the finished work, including vertical surfaces, shall be divided into regular geometric shapes. The total exposed surface area shall be arrived at by

summing up the areas of individual geometric shapes and considered for payment. The area of each geometric shape shall be worked out by measuring the length and width / height correct to the nearest centimeter. The quantities shall be rounded-off to two decimal points.

1.5.10 Providing and applying waterproof coating on parapet walls / walls.

a) Scope of work under the item.

The scope of work under this item shall be for preparing the vertical / horizontal surfaces of parapet walls / copings / walls etc., using wire brush and clean jet of water to remove the dust / organic matter / algae / fungi / grease / oil / or any other foreign matter, allowing them to dry, providing and applying two or more coats of water based acrylic elastomeric water proof / anticarbonation decorative coating (white base) as per manufacturer's specifications over a coat of water based acrylic emulsion polymer primer as per manufactures' specifications including tinting with pigments to get the approved shade of the adjacent finishes on the wall etc, as directed by Engineer-incharge. Providing & erecting knock-down type tubular steel double scaffolding with staging, strong and safe enough for execution of the item is also included under the scope of work. The same shall be dismantled disposed and cleared from the Bank's premises after completion of the work.

b) Mode of measurement.

The total surface (both vertical and horizontal) of the finished work, shall be divided into regular geometric shapes. The total exposed surface area shall be arrived at by summing up the areas of individual geometric shapes and considered for payment. The area of each geometric shape shall be worked out by measuring the length / width and width / height correct to the nearest centimeter. The quantities shall be rounded-off to two decimal points.

B. <u>List of approved makes / manufacturers / brands of materials:</u>

- 1. All materials to be used in the work shall strictly conform to the detailed technical specifications under each item.
- 2. They shall be of the best quality available in the market and conform to the relevant Indian / international standards.
- 3. If the approved brands mentioned are not available in the market, equivalent material with written approval of the Engineer-in-charge only shall be used in the work. Wherever the contractor proposes to use equivalent makes (i.e. other than those specified), the same shall be done with prior approval of the Engineer-in-charge. In such cases, it is the responsibility of the contractor to prove, to the satisfaction of the Engineer-in-charge, with necessary technical data / documents / tests reports that the equivalent materials proposed to be used in the work conform to all the technical specifications / parameters stipulated in the specifications. Any additional expenditure and time on account of this shall be solely on contractor's account and no claims whatsoever shall be entertained by the Bank in this regard.

- 4. Rates shall be quoted in Indian Rupees only.
- 5. Rates shall be submitted for all items and they shall be firm for the entire duration of the contract and any approved extended period.

Material Testing and Quality assurance Plan.

Contractor shall submit the detailed material testing and quality control plan as per the relevant IS codes and standards covering the entire scope of work as per schedule of quantity and specifications and on approval from Engineer-in-charge same shall be followed while executing the work within the cost quoted.

Schedule - C

SAFETY CODE.

- 1. First aid appliances including adequate supply of sterilized dressing and cotton wool shall be kept in a readily accessible place.
- 2. An injured person shall be taken to a public hospital without loss of time, in cases where the injury necessitates hospitalization.
- 3. Suitable and strong scaffolds should be provided for workmen for all works that cannot safely be done from the ground/floor.
- 4. No portable single ladder shall be over 8m in length. The width between the side rails shall not be less than 30cm (clear) and the distance between two adjacent rungs shall not be more than 30cm. When a ladder is used, an extra mazdoor shall be engaged for holding ladder.
- 5. The excavated material shall not be placed within 1.5m of the edge of the trench or half of the depth of trench whichever is more. All trenches and excavations shall be provided with necessary fencing and lighting.
- 6. Every opening in the floor of a building or in a working platform shall be provided with suitable means to prevent the fall of persons or materials by providing suitable fencing or railing whose minimum height shall be one meter.
- 7. No floor, roof or other part of the structure shall be so overloaded with debris or materials as to render it unsafe.
- 8. Workers employed on mixing and handling materials such as asphalt, cement mortar or concrete and lime mortar shall be provided with protective footwear and rubber hand-gloves.
- 9. Those engaged in welding works shall be provided with welder's protective eye shields and gloves.
- 10. No paint containing lead or lead products shall be used except in the form of paste or readymade paint.
- 11. Suitable facemasks should be supplied for use by the workers when the paint is applied in the form of spray or surface having lead paint dry rubbed or scrapped.
- 12. Overalls shall be supplied by the Contractor to the painters and adequate facilities shall be provided to enable the working painters to wash during the periods of cessation of work.
- 13. Hoisting machines and tackle used in the works, including their attachments, anchorage and supports shall be in perfect condition.
- 14. The ropes used in hoisting or lowering material or as a means of suspension shall be of durable quality and adequate strength and free from defects.

FIRE SAFETY CODE

- 1. Cutting / drilling machine and other electrically operated equipment used at site shall be plugged into correctly rated electrical outlets.
- 2. Only ISI marked 3 pin plug and other appliances and equipment shall be used
- 3. Electrical power cables/wires used shall not have any joints and shall be properly rated.
- 4. All electrical appliances i.e. welding, drilling, cutting machine etc. shall be safely and securely earthed to prevent leakage current while in operation.
- 5. Before commencing the welding work for the first time on any day, fire section shall be informed and only after the site inspection by the Fire officers/Personnel, work shall be started.
- 6. Two buckets of water and sand shall be kept in an easily accessible area on the site.
- 7. Fire extinguishers recommended and issued by fire officers shall be kept on the site.
- 8. Used paint drums shall be stored in specified store only after closing them properly.
- Personal protective equipment such as safety shoes, hand gloves, welder's mask, ear plug, etc., depending upon the requirement of the work shall be provided by the Contractor to the workmen to prevent occupational health hazards.
- 10. The safety belt shall be provided by the Contractor and used by the workmen while working from height for more than 10' from Ground level.
- 11. None of the passages near lift lobby and staircases shall be used for stacking / dumping any kind of materials/waste.
- 12. Both the staircase doors shall be normally kept closed.
- 13. None of the fire extinguishers shall be removed/shifted from its designated location.
- 14. Power supply shall be switched off from the mains when equipment is not in use.
- 15. Wood-shavings and saw-dust generated from the work shall be collected on daily basis, removed from site and stored at the designated place in proper manner.
- 16. Any debris generated from the work shall be collected on daily basis, removed from site and stored at the designated place in proper manner.
- 17. Battery operated emergency light/torches shall be provided by the Contractor to the workmen while working beyond office hours.

part whereby the contractor inter alia undertook to render the building and structures in the
said contract completely water and leak-proof. AND WHEREAS THE GUARANTOR agreed
to give a guarantee to the affect that the said work will remain water and leak proof, for Ten
(10) Years from the date of completion of the work under the contract.

NOW THE GUARANTOR hereby guarantee that work executed by him will render the structures completely leak proof and the minimum life of such water proofing treatment shall be Ten years to be reckoned from the date of completion of the work under the contract. Provided that the guarantor will not be responsible for leakage caused by earthquake or structural defects or misuse of roof or alteration and for such purpose: (a) Misuse of roof shall mean any operation which will damage proofing treatment, like chopping of firewood and things of the same nature which might cause damage to the roof; (b) Alteration shall mean construction of an additional storey or a part of the roof or construction adjoining to existing roof whereby proofing treatment is removed in parts; (c) The decision of the Engineer-in-Charge with regard to nature and cause of defect shall be final. During this period of guarantee, the guarantor shall make good all defects and in case of any defect being found render the building waterproof to the satisfaction of the Engineer-in-Charge calling upon him to rectify the defects failing which the work shall be got done by the Bank by some other contractor at the Guarantor's cost and risk. The decision of the Engineer-in-Charge as to the cost payable by the Guarantor shall be final and binding. That if the guarantor fails to execute the water proofing or commits breach there under, then the guarantor will indemnify the principal and his successor against all loss, damage, cost expense or otherwise which may be incurred by him by reason of any default on the part of the GUARANTOR in performance and observance of this supplementary agreement.
