**Formation of new districts in the State of Tamil Nadu –
Assignment of Lead Bank Responsibility**

The Government of Tamil Nadu vide Gazette Notifications G.O. Ms. No.425, 427, 429 and 431 dated November 12, 2019 had notified the formation of five new districts in the State of Tamil Nadu. It has been decided to assign the lead bank responsibility of the new districts as under:
